# TOURNAMENT INFORMATION

**TOURNAMENT CHECK-IN / BRIEFING DATE** August 21, 2024 **REGISTRATION REMINDER:** All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. **You will be fined for being late.**

**OFFICIAL REGISTRATION / ON SITE CHECK-IN** 2:00 pm to 4:20 pm via Time slots. Time slots will be emailed tournament week.

**TOURNAMENT BRIEFING** Virtual - All Contestants must view.

**OFFICIAL PRACTICE DAYS** August 17-21. **ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS @ 12:00 PM LOCAL TIME ON CHECK-IN DAY.** During official practice, competitors may only fish with other competitors per Rule 3ii.

**PRE -TOURNAMENT OFF-LIMITS** Off-limits will begin on Saturday August 3 and extend through Saturday, August 17 @ safelight. During this time you are not allowed on tournament waters.

**TOURNAMENT WATERS** Leech Lake and all rivers, creeks and canals connecting to Leech. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.

Leech Lake Boundaries

- County Road 38 Bridge on Kabekona River and between Kabekona Bay (Leech Lake) and Benedict Lake.
- County Road 50 Bridge on Shingobee Creek.
- State Highway 371 Bridge on the Steamboat River.
- County Road 8 Bridge on the Boy River.

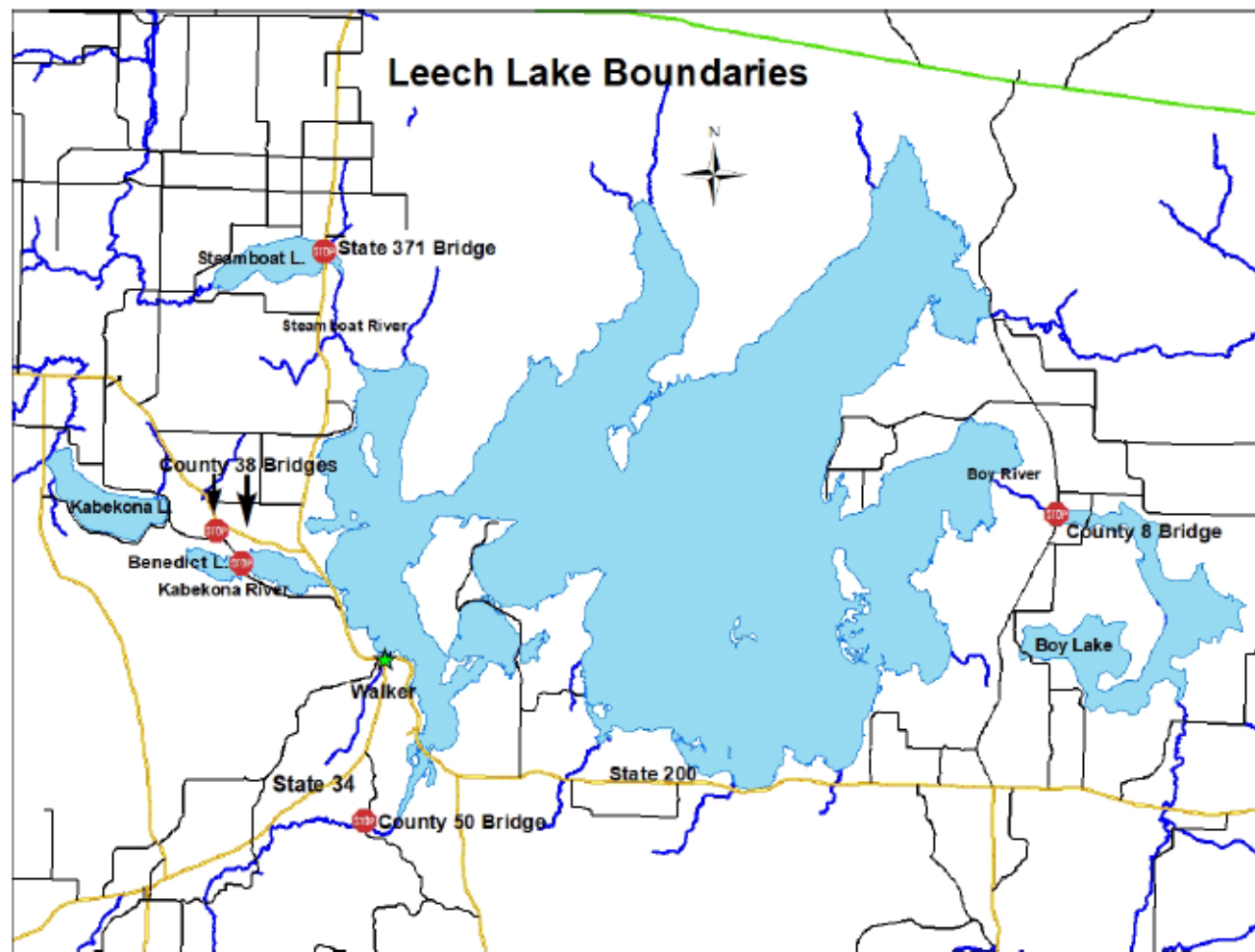
**FISH LIMITS** Pro-Angler: 5 fish / Co-Angler: 3 fish / 15" minimum length

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

**Deposits are non-refundable and non-transferable regardless of date of cancellation.** Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
