TOURNAMENT CHECK-IN / BRIEFING DATE January 22, 2025 **REGISTRATION REMINDER:** All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. **You will be fined for being late.**

OFFICIAL REGISTRATION / ON SITE CHECK-IN 10:00 am to 4:20 pm via Time slots. Onsite in person briefing and vessel electronic inspection will take place.

TOURNAMENT BRIEFING In person.

OFFICIAL PRACTICE DAYS January 19-21. **ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on January 22.** During official practice, competitors may only fish with other competitors per Rule 3ii.

PRE -TOURNAMENT OFF-LIMITS Off-limits will begin on Sunday Dec. 22 and extend through Sunday Jan. 19, @ safelight. During this time you are not allowed on tournament waters.

TOURNAMENT WATERS Clarks Hill Lake and all rivers, creeks and canals connecting to Clarks Hill. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.

Any balance of the entry fee paid in excess of the deposit will be refunded only if notification is made to the B.A.S.S. Tournament Department prior to the balance deadline date. Anglers on waiting list should not pay balance until contacted by tournament department.
