TOURNAMENT CHECK-IN / BRIEFING DATE	March 5	REGISTRATION REMINDER: All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. You will be fined for being late.

OFFICIAL PRACTICE DAYS	March 2 - 4. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on March 5. During official practice, competitors may only fish with other competitors per Rule 3ii.	
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Sunday Feb 2 and extend through Sunday March 2 @ safelight. During this time you are not allowed on tournament waters.	
TOURNAMENT WATERS	Tournament waters will be Kentucky and Barkley Lakes and all rivers, creeks and canals connected to those waters. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No locking will be permitted. Tennessee waters on Barkley Lake will be off limits.

Balance deadline dates are the dates the balances are due. You will not receive any further notices on balance due. It is the anglers' responsibility to be sure payment is made by the deadline date.

Deposits are non-refundable and non-transferable regardless of date of cancellation. Anglers on waiting list should not pay balance until contacted by tournament department.
